
OFFICE ORDER

Mr. Md. Motiur Rahman, Assistant Professor, Department of Physical & Mathematical Sciences, Faculty of Food Science & Technology (FFST), Chattogram Veterinary and Animal Sciences University (CVASU), Chattogram, Bangladesh has been granted study leave (1st time) on full average pay initially for 1(one) year with effect from 16/08/2022 to 15/08/2023 to attend the Ph.D program at the Purdue University, West Lafayette, Indiana, USA as per current revised Leave Rules 2013 (approved by 43rd Syndicate dated 06.07.2019) of this University under the following terms and conditions:

Terms and conditions:

- (1) He will draw his pay and allowance as per leave rules.
 - (2) He will not get any salary in foreign currency.
 - (3) He will not be allowed to stay abroad more than the permitted period.
 - (4) He is required to send his academic progress report through his supervisor after every semester/year.
 - (5) This granted leave may be extended subsequently on the basis of his academic progress report as per existing/Revised leave rules.
 - (6) He cannot change his registration/university/course of study without prior permission from this university authority.
 - (7) He will have to submit a report within seven days after returning from USA.
 - (8) He is required to send his overseas contact address including e-mail & telephone number.
 - (9) There is no financial involvement of this University and Government of Bangladesh for his journey/Ph.D program and all cost will be borne by the authority of the Purdue University, West Lafayette, Indiana, USA or himself.
 - (10) If there is further amendment in the present clause 30 of Leave Rules 2013 (Amended) it will be applicable for him.
