Mr. Md. Terms and conditions:

(1) He will draw his pay and allowance as per leave rules.

(2) He will not get any salary in foreign currency.

(3) He will not be allowed to stay abroad more than the permitted period.

(4) He is required to send his academic progress report through his supervisor after every semester/year.

(5) This granted leave may be extended subsequently on the basis of his academic progress report as per existing/Revised leave rules.

(6) He cannot change his registration/university/course of study without prior permission from this university authority.

(7) After successful completion of his degree, he should have to return immediately to the university and will resume the teaching.

(8) He will have to submit a report within seven days after returning from Japan.

(9) He is required to send his overseas contact address including e-mail & telephone number.

- (10) There is no financial involvement of this University and Government of Bangladesh for his journey/Ph.D course and all cost will be borne by the authority of at the National University Corporation Shizuoka University, Japan or himself.
