Terms and conditions:

- (3) Within seven (7) days of his return to Bangladesh, he must submit a joining report and a research report to the University.
- (4) Neither the University nor the Government of Bangladesh shall bear any financial responsibility or liability in connection with this visit/research. All expenses shall be borne by the University of Nebraska Medical Center (UNMC), USA or by the applicant himself.
