Terms and conditions:

(1) There is no financial involvement of this University and Government of Bangladesh for her journey/Ph.D program and all cost will be borne by the authority of the Osaka City University, Japan or herself.

(2) She will not get any salary in foreign currency.

(3) She will not be allowed to stay abroad more than the permitted period.

(4) She is required to send his academic progress report through her supervisor after every semester/year.

- (5) This granted leave may be extended subsequently on the basis of her academic progress report as per existing/Revised leave rules.
- (6) She cannot change her registration/university/course of study without prior permission from this university authority.

(7) She will have to submit a report within seven days after returning from Japan.

(8) She is required to send her overseas contact address including e-mail & telephone number.

- (9) If there is further amendment in the present clause 30 of Leave Rules 2013 (Amended) it will be applicable for her.
