### OFFICE ORDER

Mr. Nazmul Sarwar, Assistant Professor, Department of Food Processing and Engineering, Faculty of Food Science & Technology, Chattogram Veterinary and Animal Sciences University (CVASU), Chattogram, Bangladesh has been granted study leave (1st time) on full average pay initially for 1(one) year with effect from 30/09/2023 to 29/09/2024 to attend the Ph.D course at the University of Cambridge, UK as per running/revised Leave Rules 2013 (approved by 51st Syndicate dated 22/06/2022) of this University under the following terms and conditions:

#### Terms and conditions:

- (1) He will draw his pay and allowance as per leave rules.
- (2) He will not get any salary in foreign currency.
- (3) He will not be allowed to stay abroad more than the permitted period.
- (4) He is required to send his academic progress report through his supervisor after every semester/year.
- (5) This granted leave may be extended subsequently on the basis of his academic progress report as per existing/Revised leave rules.
- (6) He cannot change his registration/university/course of study without prior permission from this university authority.
- (7) After successful completion of his degree, he should have to return immediately to the university and will resume the teaching.
- (8) He will have to submit a report within seven days after returning from UK.
- (9) He is required to send his overseas contact address including e-mail & telephone number.
- (10) There is no financial involvement of this University and Government of Bangladesh for his journey/Ph.D course and all cost will be borne by the authority of University of Cambridge, UK or himself.
- 2. This order is issued as per recommendation of Planning Committee, Department of Food Processing and Engineering, Faculty of Food Science and Technology. Moreover this order is issued subject to the approval of the Syndicate of CVASU.
