DR. Terms and conditions:

- (1) She will draw her pay and allowance as per leave rules.
- (2) She will not get any salary in foreign currency.
- (3) She will not be allowed to stay abroad more than the permitted period.
- (4) She is required to send her academic progress report through her supervisor after every semester/year.
- (5) This granted leave may be extended subsequently on the basis of her academic progress report as per existing/Revised leave rules.
- (6) She cannot change her registration/university/course of study without prior permission from this university authority.
- (7) After successful completion of her degree, she should have to return immediately to the university and will resume the
- (8) She will have to submit a report within seven days after returning from Australia.
- (9) She is required to send her overseas contact address including e-mail & telephone number.
- (10) PhD course related costs will be borne by the Bangabandhu Science and Technology Fellowship Trust, Ministry of Science and Technology, Dhaka, Bangladesh (Ref. memo no. 39.09.0000.000.25.80.2020.106 dated: 06/07/2022) or herself.
- (11) If there is further amendment in the present clause 30 of Leave Rules 2013 (Amended) it will be applicable for her.
