## OFFICE ORDER

Sumi Akter, Assistant Professor, Department of Marine Bioresource Science, Faculty of Fisheries, Chattogram Veterinary and Animal Sciences University (CVASU), Chattogram, Bangladesh has been granted study leave (1st time) on full average pay initially for 1(one) year with effect from 01/08/2023 to 31/07/2024 to attend the PhD course at the University of Southern Mississippi, USA as per running/revised Leave Rules 2013 (approved by 51st Syndicate dated 22/06/2022) of this University under the following terms and conditions:

#### Terms and conditions:

- (1) She will draw her pay and allowance as per leave rules.
- (2) She will not get any salary in foreign currency.
- (3) She will not be allowed to stay abroad more than the permitted period.
- (4) She is required to send her academic progress report through her supervisor after every semester/year.
- (5) This granted leave may be extended subsequently on the basis of her academic progress report as per existing/Revised leave rules.
- (6) She cannot change her registration/university/course of study without prior permission from this university authority.
- (7) After successful completion of her degree, she should have to return immediately to the university and will resume the teaching.
- (8) She will have to submit a report within seven days after returning from USA.
- (9) She is required to send her overseas contact address including e-mail & telephone number.
- (10) There is no financial involvement of this University and Government of Bangladesh for her journey/Ph.D course and all cost will be borne by the authority of The University of Southern Mississippi, USA or herself.
- 2. This order is issued as per recommendation of Planning Committee, Department of Marine Bioresource Science, Faculty of Fisheries. Moreover this order is issued subject to the approval of the Syndicate of CVASU.
