OFFICE ORDER


Azmaien Naziat, Lecturer, Department of Fish Biology and Biotechnology, Faculty of Fisheries, Chattogram Veterinary and Animal Sciences University (CVASU), Chattogram, Bangladesh has been granted study leave on full average pay from 29/05/2026 to 28/05/2030 to attend the Ph.D course at the Adelaide University, Australia as per amended Leave Rules 2013 (Amended by 61st Syndicate) of this University under the following terms and conditions:

Terms and conditions:

- (1) She will draw her pay and allowance as per leave rules.
- (2) She will not get any salary in foreign currency.
- (3) She will not be allowed to stay leave more than the permitted period.
- (4) She is required to send her academic progress report through her supervisor after every semester/year.
- (5) The period of granted study leave may be extended subsequently on the basis of her academic progress report as per existing/Revised leave rules.
- (6) She cannot change her registration/university/course of study without prior permission from this university authority.
- (7) After successful completion of her degree, she should have to return immediately to the university and will resume the teaching/duties.
- (8) There is no financial involvement of this University and Government of Bangladesh for her Ph.D course and all cost will be borne by the authority of the Adelaide University, Australia or herself.
- (9) The period of granted study leave shall be counted as "Deputation with Active/Qualifying service" onwards determination of seniority, pension and annual increment(s). But the financial benefits of increment(s) during the period of study leave will be counted on resumption of duties after expiry of the granted leave without arrear.
